Judge Foy O'Brien called meeting to order, a quorum was established; followed by the Pledge of Allegiance.

Motion was made by Judge Dusty Kilgore, seconded by Judge Charlie Falcon to approve the minutes of the previous meeting held November 4, 2020. **Motion carried unanimously.** 

Agenda item #4 -- update from Texas Department of Health regarding the COVID-19 Vaccine Coordination was canceled by TDH.

Motion was made by Judge Greg Holly, seconded by Judge Tom Keyes to approve the Prosperity Bank for a two-year extension for the banking institution contract for the PBRPC. **Motion** carried unanimously. **RESOLUTION # 2020-71** 

Motion was made by Judge Tom Keyes, seconded by Judge Charlie Falcon to approve the PBRPC Investment Report for the period ending September 30, 2020. **Motion carried unanimously. RESOLUTION # 2020-72** 

Motion was made by Judge Dusty Kilgore, seconded by Charlie Falcon to approve the PBRPC check and payroll register for the month of November. **Motion carried unanimously. RESOLUTION #2020-73** 

Virginia Belew, Interim Executive Director, provided an update for the Financial Director position. Stating there were (4) applicants and (3) of the applicants did not pass the criminal background check, the other had issues at their previous employment. She also mentioned the staffing agency would charge a fee of \$16,000 as a portion of the annual percentage should it be decided to go with the staffing agency. Judge Greg Holly also stated they should consider Lisa Granado's application for this position based on her experience.

The Financial Director interview committee provided an update on the effort made to fill the position, indicating an extended period for recruitment and selection is necessary. Motion was made by Judge Dusty Kilgore, seconded by Judge Brian Cox to allow the Executive Committee to interview applicants and make their recommendations to the Board, instead of waiting until the next meeting for entire board interview participation. **Motion carried unanimously.** 

The PBRPC Board of Directors set the next meeting for January 27, 2021.

Motion was made by Judge Dusty Kilgore, seconded by Judge Tom Keyes to adjourn the meeting. **MOTION CARRIED UNANIMOUSLY.**
